**BOARD RESOLUTION NO. 06 SERIES OF 2014**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) was created by Executive Order No. 202 dated June 19, 1987, as administrative agency with quasi-judicial powers, and is the existing franchising and regulatory body for land transportation today;

**WHEREAS**, on June 17, 2014, this Board issued Memorandum Circular No. 2014-008, Re CLARIFICATION INSOFAR AS TH FREIGHT TRUCK SERVICES IN THE IMPLEMENTATION OF JOINT ADMINISTRATIVE ORDER NO. 2014-001;

**WHEREAS**, the Board was directed on October 13, 2014 by the Cabinet Cluster on Manila Port Congestion to continue accepting new applications for TH services of identified port users of Port of Manila and to issue Provisional Authority valid and effective until January 31, 2015;

**WHEREAS**, the Board takes into consideration the coming holiday season, which will result in a huge volume of cargoes entering the Port of Manila;

**WHEREAS**, the Board fully supports the national government's commendation to extend the issuance of Provisional Authority to truck port users to ensure the sufficiency and availability of cargo trucks to decongest the Port of Manila.

**NOW, THEREFORE**, the Board resolves these concerns by releasing these guidelines:

**I. WHO ARE QUALIFIED TO FILE FOR PROVISIONAL AUTHORITY (PA)?**

- All pending TH Applications of identified port users of the Port of Manila which were not granted PA having been filed after August 15, 2014.

*Requirements: Motion for Issuance of PA*

*Permit to Operate issued by the Philippine Ports Authority*

- All dismissed Applications for TH Services of identified port users of the Port of Manila.

*Requirements: Motion for Reconsideration with Motion for Issuance of PA*

*Permit to Operate issued by the Philippine Ports Authority*

- Applications for New CPC for TH Services of identified port users of the Port of Manila to be filed beginning October 20, 2014 up to January 31, 2015.

*Requirements: Please visit our website [www.ltfrb.gov.ph](http://www.ltfrb.gov.ph)*

**NOTE:** Please bring original Permit to Operate for comparison with photocopy.

**II. WHO WILL ISSUE THE PROVISIONAL AUTHORITY?**

- Upon favorable recommendation of the Technical Division, the Executive Director of the Board, Atty. ROBERTO P. CABRERA III, is hereby authorized to sign the Provisional Authority.

**III. VALIDITY PERIOD OF THE PROVISIONAL AUTHORITY.**

- January 31, 2015.
