Invitation to Bid for

REHABILITATION AND EXPANSION OF EXISTING LTFRB MAIN BUILDING

- 1 The Land Transportation Franchising and Regulatory Board (*hereinafter referred to as "LTFRB"*), through the *2015 GAA Locally Funded Projects* intends to apply the sum of **TWENTY FIVE MILLION NINE HUNDRED FORTY NINE THOUSAND FIFTY PESOS AND FORTY FOUR CENTAVOS (₱ 25,949,050.44)** being the Approved Budget for the Contract (ABC) to payments under the contract for **REHABILITATION AND EXPANSION OF EXISTING LTFRB MAIN BUILDING**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 - 2 The LTFRB now invites bids for **REHABILITATION AND EXPANSION OF EXISTING LTFRB MAIN BUILDING**. Completion of the Works is required *within three hundred sixty (360) calendar days inclusive of 75 pre-determined unworkable days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 - 3 Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4 Interested bidders may obtain further information from BAC Secretariat/Procurement Section, 3rd Floor, LTFRB Bldg., East Avenue, Quezon City and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M. from Monday to Friday.
 - 5 A complete set of Bidding Documents may be acquired by interested bidders from **14 July 2017 until 2:00 PM of 7 August 2017** at 3rd Floor LTFRB Bldg., East Avenue, Quezon City and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (₱ 25,000.00)**.

The same may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (www.ltfrb.gov.ph), *only those bidders who purchased the Bidding Documents shall be allowed to submit bids.*

- 6 The *LTFRB* will hold a Pre-Bid Conference on **24 July 2017, 2:00 PM** at the Mini-conference room, 3rd Floor, LTFRB Bldg., East Avenue, Quezon City, which shall be open to prospective bidders.
- 7 Bids must be duly received by the BAC on or before **7 August 2017, 2:00 PM** at the address given below. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.


Bid opening shall be on **7 August 2017, 2:15 PM** at the Mini-conference room, 3rd Floor, LTFRB Bldg., East Avenue, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8 The *LTFRB* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
