

**INVITATION TO BID**  
**FOR THE SUPPLY, DELIVERY AND INSTALLATION OF CLOSE**  
**CIRCUIT TELEVISION CAMERA (CCTV) FOR 2017 TO THE LAND**  
**TRANSPORTATION FRANCHISING AND REGULATORY BOARD –**  
**CENTRAL AND REGIONAL OFFICES**

1. The Land Transportation Franchising and Regulatory Board, through the General Appropriations Act (GAA) of CY 2017 intends to apply the sum of **One Million Six Hundred Thirty Thousand Nine Hundred Thirty Pesos only (Php1,630,930.00)** being the Approved Budget for the Contract (ABC) for the Supply, Delivery and Installation of Close Circuit Television Camera (CCTV) for 2017 – Central and Regional Offices. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LTFRB now invites bids for the Supply, Delivery and Installation of Close Circuit Television Camera (CCTV). Delivery of the goods and services are required for a period of sixty (60) days. Bidders should have completed, within the past three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from BAC Secretariat/Procurement Unit, Ground Floor- Central Office, Land Transportation Franchising and Regulatory Board (LTFRB), East Avenue, Quezon City and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm from Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on August 25, 2017 to September 18, 2017 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Philippine Pesos Five Thousand only (Php 5,000.00)

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The LTFRB will hold a **Pre-Bid Conference** on **4 September 2017** at **2:00 pm** at the LTFRB Mini Conference Room, 3<sup>rd</sup> Floor, East Avenue, Quezon City which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **18 September 2017, 2:00 pm**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **18 September 2017, 2:30 pm** at LTFRB Mini-Conference Room, 3<sup>rd</sup> Floor, East Avenue, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The LTFRB reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
