**NEGOTIATED PROCUREMENT (2-BID FAILURE) FOR THE
CONSULTANCY SERVICES FOR THE CONDUCT OF LOCAL PUBLIC
TRANSPORTATION ROUTE PLANNING AND
MANAGEMENT COURSE**

1. In view of the two (2) failed biddings held on September 15, 2017 and September 23, 2017, the Land Transportation Franchising and Regulatory Board (LTFRB), through its Bids and Awards Committee invites Philgeps registered service providers to participate in the Negotiated Procurement for the project, Consultancy Services for the Conduct of Local Public Transportation Route Planning and Management Course in accordance with Section 53.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".
2. The Approved Budget for the Contract is Sixty Million Pesos Only (PhP60,000,000.00) inclusive of taxes. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
3. For more details of this project, please refer to the attached Bidding Documents.
4. Pre-Bid Conference shall be held on December 1, 2017 at 10:00 am at the LTFRB Conference Room, LTFRB Central Office, 3rd Floor, LTFRB Main Building, East Avenue, Quezon City.

The Eligibility and Technical Documents as well as the Financial Proposal Form shall be submitted on or before December 14, 2017 at 9:00 a.m. at the LTFRB Conference Room, LTFRB Central Office, 3rd Floor, LTFRB Main Building, East Avenue, Quezon City.

5. The Procuring Entity shall evaluate proposals using the Quality Cost Based Evaluation (QCBE) procedure. Bids whose technical proposal passed the minimum technical requirement of seventy five (75%) shall have its financial proposals opened and

evaluated. The technical proposal shall carry eighty percent (80%) weight in the evaluation and the financial proposal twenty percent (20%). The evaluation criteria for technical and financial proposal shall be in accordance with the guidelines prescribed under the Revised Implementing Rules and Regulations (IRR) of R.A. 9184.

6. The contract shall be completed within eighteen (18) months reckoned from the Consulting Firm's receipt of the Notice to Proceed issued by the Head of the Procuring Entity.
