INVITATION TO RE-BID FOR THE SUPPLY AND DELIVERY OF PULL-TIGHT AND TAXI METER SEAL FOR FY 2015

1. The **LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD – CENTRAL OFFICE (LTFRB-CO)**, through the 2015 General Appropriations Act, intends to apply the sum of **THREE MILLION FIVE HUNDRED THOUSAND PESOS (Php3,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of 80,000 pieces of Pull-Tight and Taxi Meter Seal for FY 2015**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LTFRB-CO now invites bids for the **Supply and Delivery of 80,000 pieces of Pull-Tight and Taxi Meter Seal for FY 2015**. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project with an amount of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from LTFRB and inspect the Bidding Documents at the address given below from 9:00 am to 5:00 pm from Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders from **February 20 – March 11, 2015** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB) in the amount of **Php5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The LTFRB will hold a Pre-Bid Conference on **February 24, 2015 at 10:00 in the morning at the LTFRB Conference Room, 3rd Flr, LTFRB Central Office Building, East Avenue, Quezon City**, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before **March 11, 2015 at 2:00 in the afternoon**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
7. Bid opening shall be on **March 11, 2015 at 2:10 P.M. at the LTFRB Conference Room, 3rd Flr., LTFRB Central Office Building, East Avenue, Quezon City**. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. **Late bids shall not be accepted.**
8. The LTFRB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
