BOARD RESOLUTION No. 14
Series of 2016

WHEREAS, Chairman Atty. Martin B. Delgra III and Board Member Atty. Aileen Lourdes A. Lizada will be attending a training on “Regulation Monitoring of Road-Based Public Transport using IT-Based System” in Seoul, Republic of Korea, organized by Intelligent Transport Society of Korea (ITS Korea) and hosted by the Ministry of Land, Infrastructure and Transport (MOLIT) on October 24-28, 2016;

WHEREAS, Memorandum Order No. 2016-017 was issued on October 20, 2016 by Chairman Martin B. Delgra III designating Board Member Ronaldo F. Corpus as Officer-in-Charge in the absence of the former from October 24-28, 2016;

WHEREAS, given the proximity of a special holiday (All Saints Day), and the necessity of issuing Special Permits to operators of Public Utility Bus (PUB) Service brought about by the volume of passengers and the increased demand for public transport during the said holiday, there is an urgent need to designate an official to act on and approve Petitions for Special Permit in the absence of the two (2) members of the Board on October 24-28, 2016;

NOW THEREFORE, the Board hereby resolves, in the exigency of the service, to delegate the authority to **ACT ON** and **APPROVE** Petitions for Special Permit to Board Member **RONALDO F. CORPUS** as Officer-in-Charge during the period of absence of Chairman Martin B. Delgra III and Atty. Aileen Lourdes A. Lizada from October 24-28, 2016.

It is further resolved that the limitation on the total number of Special Permits per operator to not exceed 25% of its total number of authorized units, as prescribed under Board Resolution No. 13, Series of 2016, is hereby **LIFTED**.

Likewise, the duration of the Special Permit for All Saints Day is **EXTENDED** to October 29, 2016 – November 3, 2016.

Finally, let a copy of this Resolution be furnished to all our Regional Offices for their appropriate guidance.
