WHEREAS, on March 26, 2014, the Board issued Board Resolution No. 03 Series of 2014 granting special permit allowing existing grantees of Certificates of Public Convenience in Ilocos Region, Cagayan Valley Region, and Cordillera Regions who opt to apply for Special Permit to Operate Out of Line Operations to operate PUB services on 14 routes identified therewith;

WHEREAS, after a careful study of the situation on other areas/routes affected by the suspension of G.V. Florida not specifically identified in Board Resolution No. 3, the Board decided to add additional routes which will be opened for the issuance of a Special Permit;

NOW THEREFORE, and in view of the foregoing, the Board resolves to allow existing grantees of Certificates of Public Convenience to Operate PUB Services in Ilocos Region, Cagayan Valley Region, and Cordillera Administrative Regions to apply for Special Permit to Operate Out of Line Operations on the following additional routes subject to existing policies and guidelines of this Board in granting special permit to operate out of line operations:
