**BOARD RESOLUTION NO. 09 Series of 2014**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) was created by Executive Order No. 202 on June 19, 1987, as administrative agency with quasi-judicial powers, and is the existing franchising and regulatory body for land transportation today;

**WHEREAS**, on June 2, 2014, Joint Administrative Order 2014-01, entitled REVISED SCHEDULE OF FINES AND PENALTIES FOR VIOLATIONS OF LAWS, RULES AND REGULATIONS GOVERNING LAND TRANSPORTATION was issued by this Board and the Land Transportation Office, and approved by the Honorable Secretary of Department of Transportation and Communications;

**WHEREAS**, the Joint Administrative Order (JAO) 2014-01 provides that the LTFRB shall hear and decide all franchise violations, such as Public Utility Vehicles engaging in out of line operations defined and penalized under Part IV, item 1, Paragraph b thereof;

**WHEREAS**, during consultation meeting with the grantees of Taxi Air-Conditioned services, concerns about the implementation of JAO particularly the out of line operations of taxis with a penalty of PhP200,000.00 was brought out, and there was a clamor that they be allowed to expand their respective area of operation and be allowed to operate outside of Metro Manila due to vast development and new found residence of some of the passengers in the nearby provinces of Rizal, Bulacan, Laguna, and Cavite;

**WHEREAS**, after review of existing issuances of this Board relative to expansion/ change area of operation of taxi services, and considering that resealing and inspection area of the Board is located at Taytay, Rizal, which is outside the Metro Manila area, this Board deems it necessary to direct grantees planning to expand their operations to file the necessary application/petition for change area of operations pursuant to Memorandum Circular 2012-021, Re: CHANGE AREA OF OPERATION , and Memorandum Circular 2013-001, Re: CLARIFYING MC 2012-021.





2. The Regional Director of LTFRB-NCR is hereby ordered to act on the Motions to be filed within fifteen (15) days from receipt thereof.


