**RESOLUTION NO. 001 Series of 2018**  
**(Re: COMPLIANCE OF GENESIS TRANSPORT SERVICE, INC. AND**  
**RECONSIDERATION OF VICTORY LINER, INC. FOR ADDITIONAL**  
**PREMIUM POIN TO POINT SERVICE)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on the evaluation of pre-qualification documents submitted by applicants of P2P Service under Memorandum Circular No. 2017 -25, Re: IMPLEMENTING GUIDELINES ON THE OPENING OF PROPOSED ADDITIONAL PREMIUM POINT-TO-POINT SERVICES, the Pre-Qualification Committee required Genesis Transport Service, Inc. (Package 1 Applicant) to submit within seven (7) days the following: (1) an Undertaking that the proposed Bus depot/garage situated in Prado Siongco, Lubao, Pampanga shall not be used for other public transport service; (2) clear copy of Transfer Certificate of Title No. 492986-R on the property situated in San Fernando, Pampanga to be used by the applicant as its P2P off-street loading/unloading for the Clark to Lubao. Pampanga Route,

**WHEREAS**, Victory Liner, Inc. (Packages 2 and 3 Applicant) was ruled not qualified due to inadmissibility of the Audited Financial Statement submitted by Victory Liner on the basis of the illegibility of the stamp "Received" by the Bureau of Internal Revenue

**WHEREAS**, Compliance and Manifestation was filed by Genesis Transport Service, Inc on November 23, 2017 attaching therewith the Original Sworn Undertaking dated November 22, 2017, and the Certified True Copies of TCT Nos. 492985-R, 492986-R and 492987-R

**WHEREAS**, Victory Liner, Inc. filed its Motion for Reconsideration on November 22, 2017 relative to the inadmissibility of the Audited Financial Statement (AFS) submitted, and attached therewith its receiving copy of AFS

with traces of BIR's stamp "received" dated April 21, 2017, and copy of Certification from BIR representative whose stamp and signature appears in the Certified True Copy submitted by Victory Liner, inc.. ;

**WHEREAS**, the Committee has deliberated on the aforementioned compliance of Genesis Transport Service, Inc. and request for reconsideration of Victory Liner, inc. and revisited the implementing guidelines provided under MC 2017-025 particularly the items thereat subject of the compliance and reconsideration;

**NOW THEREFORE**, the Pre Qualification Committee resolves to as it is hereby resolved to:

1. **CONSIDER** the Compliance and Manifestation of GENESIS TRANSPORT, SERVICE INC. to be in accordance with the requirement of the committee, including the documents required for submission;
2. **GRANT** the request for reconsideration of VICTORY LINER, INC. as it established sufficiently that its Audited Financial Statement was received by the BIR on April 21, 2017 per Certification issued by the BIR representative ;
3. **DIRECT** the Technical Working Group to proceed with the evaluation of qualification documents of GENESIS TRANSPORT SERVICE, INC. and VICTORY LINER, INC.
