## BOARD RESOLUTION No. Ol3 Series of 2018

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) was created by Executive Order No. 202 on June 19, 1987 as an administrative agency with quasi-judicial powers and is the existing franchising and regulatory body for land transportation services.

WHEREAS, pursuant to Section 38, Chapter V of Commonwealth Act No. 146 otherwise known as the Public Service Law, the chief of the legal division or any other attorneys of the Commission shall represent the same in all judicial proceedings.

WHEREAS, by virtue of Office Order No. 2016-198, Atty. Carl Sha Jemimah F. Marbella, was designated by the Board as Officers-in-Charge, in a concurrent capacity, of the Legal Division and Office of the Executive Director of the LTFRB, effective 01 September 2016.

WHEREAS, on 22 September 2017 the Board, represented by the OIC-Chief of the Legal Division, filed a criminal case against Mr. George San Mateo for violation of Section 20 (k) of C.A. No. 146 otherwise known as the Public Service Law which is now pending before Branch 43 of the Municipal Trial Court of Quezon City under Criminal Case No. 12-12657.

**NOW THEREFORE**, premises considered, the Board hereby AUTHORIZES Atty. CARL SHA JEMIMAH F. MARBELLA, as OIC-Chief of the Legal Division of the LTFRB to perform the following acts:

- 1. REPRESENT the LTFRB as nominal Complainant in Criminal Case No. 17-12657 entitled People of the Philippines vs. George F. San Mateo;
- 2. ATTEND and APPEAR in behalf of LTFRB in the Pre-Trial Proceedings and all subsequent hearings in Criminal Case No. 17-12657 entitled People of the Philippines vs. George F. San Mateo;
- 3. To SIGN and ENTER into amicable settlement, compromise agreement, submit to alternative modes of dispute resolution and to do any and all other acts necessary and
