

RESOLUTION NO. 033 Series of 2018

(Re: ACCREDITATION OF MICAB SYSTEMS CORPORATION AS TRANSPORTATION NETWORK COMPANY)

WHEREAS, on 28 March 2018, the Committee issued Resolution No. 021 series of 2018 wherein the committee resolved:

"NOW THEREFORE, premises considered, the Committee resolves to DIRECT applicant Micab Systems Corporation to SUBMIT within Fifteen (15) days from receipt of this Resolution the following supporting documents:

- a.) Business Permit duly issued by the Local Government where the Applicant's principal place of business is located; and
- b.) Audited or Interim Financial Statement as proof of applicant's financial capability.

Applicant is further directed to FILE its Position Paper within Fifteen (15) days from receipt of this Resolution, on the following issues:

- a.) The company is not a Transport Provider; and
- b.) Disclaimer of liabilities as a TNC.

Failure to submit/comply within the period specified herein, the Committee shall be constrained to treat the same as a withdrawal of the application with forfeiture of any payments paid by the applicant to the LTFRB."

WHEREAS, Prior to the issuance of Resolution No. 021, the Applicant already submitted on 23 March 2018 the following documents:

- Business Permit issued on 20 March 2018 by the City of Cebu
- Audited Financial Statement

WHEREAS, on 05 April 2018, Applicant Micab filed its Position Paper in Compliance with Resolution No. 021 the merits of which, were deliberated upon by the Committee.

WHEREAS, on 19 April 2018, the applicant filed a Manifestation and submitted its revised Business Model Description and Declarations on Micab's Financial Capability, Ability to Pay for Insurance Coverage, and Ability to Provide Safe, Lawful, Convenient Transportation to support the application and to show the revenue channel of the business model.

WHEREAS, on 25 April 2018, the applicant submitted another Manifestation containing further revision of the Business Model Description and Declarations on Micab's Financial Capability, Ability to Pay for Insurance Coverage, and Ability to Provide Safe, Lawful, Convenient Transportation that the Applicant earlier submitted through a Manifestation on 19 April 2018.

NOW THEREFORE, premises considered, finding the Application of Micab Systems Corporation complete and compliant with MC No. 2015-015-A, the Committee hereby recommends to the Board to GRANT the Application of Micab Systems Corporation for a Certificate of Accreditation as a Transportation Network Company.
