

RESOLUTION NO. 036 Series of 2018
(Re: ACCREDITATION OF MOBER TECHNOLOGY PTE INC. AS
TRANSPORTATION NETWORK COMPANY)

WHEREAS, pursuant to Memorandum Circular No. 2015-015-A (Re: Rules and Regulations to Govern the Accreditation of Transportation Network Companies) a Pre-Accreditation Committee was created to evaluate all applications for Transportation Network Company (TNC) accreditation filed before the LTFRB and recommend to the Board its approval and disapproval;

WHEREAS, on April 30, 2018, the Committee conducted its evaluation of the documents submitted by Mober Technology PTE Inc.

WHEREAS, during the scheduled evaluation, the Committee found that Mober Technology PTE Inc. has apparently filed its Application for Accreditation as Transportation Network Company on 13 June 2016 as per the attached "Receiving Copy" which on its face appears to have been signed by Ms. Esther Joy Evasco of the Office of Board Member Engr. Ronaldo F. Corpus.

WHEREAS, a copy of the aforesaid application for accreditation filed on 13 June 2016 is not attached to the record before the Committee.

WHEREAS, a copy of the receipt dated 13 June 2016 numbered 6771783 in the amount of ten-thousand pesos (Php 10,000.00) is attached to the record in connection with the previously filed application (re: Payment of non-refundable accreditation fee for the application for issuance for the Certificate of TNC accreditation).

NOW THEREFORE, premises considered, the Committee resolves to DIRECT applicant Mober Technology PTE Inc. TO SUBMIT within Ten (10) days from receipt of this Resolution the following documents:

- a) Original copy of the "Receiving Copy" which was submitted to LTFRB on 13 June 2016 received by Ms. Esther Joy Evasco.
- b) A copy of the Application for Accreditation also submitted on 13 June 2016.

Ms. Esther Joy Evasco is further required to IDENTIFY and CONFIRM the submitted documents by herein applicant as stated in this Resolution.

Failure to submit/comply within the period specified herein, the Committee shall be constrained to treat the same as a withdrawal of the application with forfeiture of any payments paid by the applicant to the LTFRB.
