

RESOLUTION NO. 039 Series of 2018
(Re: PRE QUALIFICATION OF ADDITIONAL
PREMIUM POINT TO POINT SERVICE UNDER MC 2017-014)

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

WHEREAS, on the scheduled date provided under Memorandum Circular No. 2017 -014, Re: IMPLEMENTING GUIDELINES ON THE OPENING OF PROPOSED ADDITIONAL PREMIUM POINT-TO-POINT SERVICES, or on July 31, 2017 from 9:00 AM to 2:00 PM, the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

1. DELTA NEOSOLUTIONS, INC.
2. DE GUIA ENTERPRISES, INC.
3. RRCG TRANSPORT SYSTEM CO., INC
4. DARLYN M. AGA

 - 1.3. Board Resolution No, 2017-07 of 3A BOYS CORP. allowing DARLYN M AGA to utilize all real properties registered under the name of the former as they may deem fit.
