ANSWERS OF INVENTORY AND DISPOSAL COMMITTEE TO THE QUERIES FROM PROSPECTIVE BIDDERS

QUERIES	ANSWERS
1. When can losing bidders refund their bid bonds?	1. After the issuance of Notice of Award to the winning bidder.
2. When the highest bidder repudiated his bid, what would be the amount to be paid by the second highest bidder, would it be the bid price of the highest bidder or the bid price of the second highest bidder?	2. Bid price of the second highest bidder.
3. Can they do some cutting of materials inside LTRFB premises?	3. Yes
4. Will the winning bidder be given permit by the Inventory and Disposal Committee to claim/ pull-out the items subject of the bid?	4. Yes
5. Is the presence of COA (Commission on Audit) representative during claiming/ pulling-out of items, required?	5. Yes, but COA may waive their presence.
6. Can the winning bidder get from LTRFB the Official Receipt and Certificate of Registration (OR/CR) and the same be registered to him/her?	6. Yes
7. Do losing bidders have to wait for the issuance of Notice of Award to the winning bidder before they can request for the refund of their bid bond?	7. No. Only the bid bond of the first 3 highest bidders will have to wait .
