

**RESOLUTION NO. 058 Series of 2018**

(Re: ACCREDITATION OF MOBER TECHNOLOGY PTE INC. AS  
TRANSPORTATION NETWORK COMPANY)

**WHEREAS**, on 7 May 2018, the Committee issued Resolution No. 036 Series of 2018 wherein the committee resolved:

**"NOW THEREFORE**, premises considered, the Committee resolves to DIRECT applicant Mober Technology PTE Inc. TO SUBMIT within Ten (10) days from receipt of this Resolution the following documents:

- a) Original copy of the "Receiving Copy" which was submitted to LTFRB on 13 June 2016 received by Ms. Esther Joy Evasco.
- b) A copy of the Application for Accreditation also submitted on 13 June 2016.

Ms. Esther Joy Evasco is further required to IDENTIFY and CONFIRM the submitted documents by herein applicant as stated in this Resolution."

**WHEREAS**, on 17 May 2018, the applicant Mober Technology PTE Inc. submitted documents in compliance with the Resolution No. 036 Series of 2018, received by the Office of the Executive Director, and an evaluation was thereafter conducted by the Committee on 26 June 2018.

**WHEREAS**, in the documents for compliance, the herein applicant also submitted the original copy of the Order of Payment and the Official Receipt numbered 6771783 dated 13 June 2016.

**WHEREAS**, the committee found that the herein applicant was able to comply with the Item (a) but failed to comply with Item (b) of the Resolution No. 036 Series of 2018.

**WHEREAS**, in the second paragraph (highlighted) in the cover letter of the documents for compliance submitted by the herein applicant, it stated thus:

"This is to state that Mober have not submitted any Application for Accreditation and only comply with all the requirements list on the Receiving Copy from the attached documentation provided by the LTFRB in the year 2016."

**WHEREAS**, pursuant to Item (II) first paragraph of the Memorandum Circular No. 2015-015 dated 28 May 2015, it stated thus:

**"An Application for the Issuance of a Certificate of Accreditation shall be made in writing on a form provided by the Board, and signed and sworn to by the applicant,** or if the applicant is juridical entity, by its duly authorized representative. Each Application, in addition to other documents that are required, shall submit at a minimum the following:"

(emphasis ours.)

**NOW THEREFORE**, premises considered, this Committee resolves to DENY applicant Mober Technology PTE Inc.'s petition for accreditation as a Transportation Network Company due to its failure to comply with Item (b) of the Resolution No. 036 Series of 2018.
