

RESOLUTION NO. 087 Series of 2018

(Re: ACCREDITATION OF RYD GLOBAL, INC. AS
TRANSPORTATION NETWORK COMPANY)

WHEREAS, on July 12, 2018, the Committee issued Resolution No. 062 series of 2018 wherein the committee resolved:

"NOW THEREFORE, premises considered, the Committee resolves to DEFER the evaluation of the documents submitted by applicant RYD Global, Inc. The applicant is hereby directed TO SUBMIT its complete supporting documents as prescribed under MC No. 2015-015-A within Ten (10) days from receipt of this Resolution for speedy disposition of the Committee. Otherwise, failure to submit/comply within the period specified herein, the Committee shall be constrained to treat the same as a withdrawal of the application with forfeiture of any payments paid by the applicant to the LTFRB.

In the submission of its application and supporting documents, the applicant is hereby enjoined to STRICTLY comply with the provisions of MC No. 2015-015-A."
