

**RESOLUTION NO. 028 Series of 2018**  
**(Re: PRE QUALIFICATION OF ADDITIONAL**  
**PREMIUM POINT TO POINT SERVICE UNDER MC 2017-034)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on the scheduled date provided under Memorandum Circular No. 2017-034, RE: IMPLEMENTING GUIDELINES ON THE OPENING OF PROPOSED ADDITIONAL PREMIUM POINT-TO-POINT SERVICES, or on January 31, 2018 from 9:00 AM to 2:00 PM, CITY STAR TRANSPORT CORP. (Applicant) submitted its Qualification Documents for its Application for PACKAGE 7A for the route: MALABON/NAVOTAS – PASAY via R10 with the TOTAL UNITS of 15;

**WHEREAS**, during the opening of the Qualification Documents by the Pre-Qualification Committee on 01 February 2018, the committee ruled the applicant as not qualified for failure to submit a notarized certification from the supplier, assembler or manufacturer indicating therein the proposed delivery schedule of the units;

**WHEREAS**, on 05 February 2018, Applicant CITY STAR TRANSPORT CORP. submitted a letter of reconsideration. Accordingly, the Committee deliberated on the aforementioned letter of reconsideration and revisited the implementing guidelines provided under Memorandum Circular No. 2017-034 particularly the items thereat subject of the reconsideration;

**WHEREAS**, the Committee directed the Technical Working Group to re-evaluate the qualification documents submitted by the Applicant.

**WHEREAS**, the Applicant applying for PACKAGE 7A for the route: MALABON/NAVOTAS – PASAY via R10 was given by the Committee a rating of "QUALIFIED" as it submitted complete Qualification Documents with attachments and was given a rating of "PASSED";

**NOW THEREFORE**, the Pre-Qualification Committee resolves to as it is hereby resolved to RECOMMEND to the Board to:

**AWARD** in favour of **CITY STAR TRANSPORT CORP.** to process further its Application for **PACKAGE 7A** for the route: **MALABON/NAVOTAS – PASAY** via R10 of the PREMIUM POINT TO POINT SERVICE under Memorandum Circular No. 2017-034;
