

## **BOARD RESOLUTION NO. 090 Series of 2018**

(Re: ACCEPTANCE OF APPLICATION FOR THE ISSUANCE OF NEW CPC TO OPERATE ADDITIONAL UV EXPRESS SERVICE UNITS IN DEVELOPMENTAL ROUTES IN THE CARAGA REGION)

**WHEREAS**, in a letter dated 16 July 2017, Representative Erlpe John M. Amante, 2<sup>nd</sup> District of Agusan del Norte referred to the DOTr the letter of Cabadbaran City Mayor Katrina O. Mortola, Nasipit Mayor Enrico R. Corvera and Kitcharao Mayor Aristotle E. Montante requesting for the issuance of additional and/or new CPCs to operate UV Express Services on the routes between their respective communities and Butuan City;

**WHEREAS**, LTFRB CARAGA Region Acting Regional Director Nordy L. Plaza in a Memorandum dated 27 July 2018 requested for the opening of new/developmental UV Express and developmental routes in the region in view of the deficiency of public land transportation in connecting certain urban areas in the Region;

**WHEREAS**, in a Memorandum dated 22 October 2018 addressed to the LTFRB Chairman, Asec. Mark Richmund M. De Leon, OIC-Undersecretary for Road Transport and Infrastructure endorsed the opening of additional units to the following new/developmental routes within the Province of Agusan del Norte, to wit:



**NOW THEREFORE**, premises considered, this Board hereby authorizes the acceptance of applications for the issuance of New CPCs to operate UV Express Service for the routes described below subject to the following conditions:

Butuan City – Nasipit	26.3 km	30	UV Express	Intra-provincial
Butuan City – Cabadbaran	29 km	30	UV Express	Intra-provincial
Butuan City - Kitcharao	73 km	15	UV Express	Intra-provincial

1. Applications for the Issuance of New CPC shall be accepted for processing by the LTFRB-CARAGA on the above mentioned new/developmental routes.
2. All UV Express Service shall strictly operate on a point-to-point basis. All PUVs shall have designated terminals at both end points.
3. All intra-provincial routes shall be subject to the results of the Local Public Transport Plan (LPTRP) of the concerned Provincial Government. All operators shall, upon filing of the Application, execute an undertaking stating that they will immediately comply with the approved DOTr route rationalization study and LPTRPs, as the case may be.
4. Applicants for new CPC on the above-stated new routes shall consolidate under the one route-one franchise scheme consistent with the Industry Consolidation Component under the PUVMP. Priority shall be accorded to existing transport cooperatives/corporations whose operations are situated near/adjacent to the routes applied for.
5. Current Units not older than three (3) years old for UV Express routes, shall be allowed under Provisional Authority (PA) pending the issuance of the CPC and delivery of the OFG-compliant units. By June 30, 2020, only OFG-Compliant units shall be authorized;
6. A Provisional Authority may be issued for a period of Forty-Five (45) days upon the Acceptance of Application provided that a photocopy of the passenger insurance policy is submitted.
7. An additional amount of Two Hundred Sixty Pesos (Php 260.00) shall be paid by applicants if they pray for the issuance of PA in the Application of in a separate motion.
8. Only for this Board Resolution, the Butuan City – Kitcharao route is hereby exempted from the maximum distance policy.
9. Copies of this Board Resolution shall be posted at the Bulletin Board of the DOTr – CARAGA office.
