MEMORANDUM CIRCULAR
NUMBER 88-016

SUBJECT : Special Permit for PU Minica Service

DATE : 29 June 1988

In view of the requests of PU Minica operators for further extension of PU Minica service and after a thorough study of its implication on public need and safety as well as the current situation on the availability of economically viable substitute units, the LTFRB hereby adopts a policy of granting a Special Permit instead of issuing an automatic extension for the operation of PU Minica units to all PU Minica operators which shall be valid for two (2) years effective June 30, 1988, subject to the following conditions:

1. Operators must file the necessary petition and pay the corresponding filing fees.
2. They must settle all their accounts with the Board, if there are any.
3. The units must be certified to be roadworthy.
4. Operation of PU Minica service shall be limited within the territorial boundary of each of the following cities defined as follows:

A. Region VI

Bacolod City - Within the territorial boundary of Bacolod City, Bago City to the South and Victorias, Negros Occidental to the North.

Iloilo City - Within the territorial boundary of Iloilo City specifically defined by the following districts/areas:

Villa	Jaro	Manduriao
Molo	Bo. Obrero	La Paz

B. Region VII

Metro Cebu - Cebu City & Municipality of Talisay in the South.

Mandawe City and Municipality of Consolacion in the North. *JMT*

Lapu-Lapu City proper and municipality of Cordova, Mactan Island except Mactan Int. Airport *SL*

Cagayan de Oro City - Within the territorial boundary of Cagayan de Oro City specifically defined by the following districts/areas:
