



MEMORANDUM CIRCULAR  
NUMBER 2003-017

*Subject:* AMENDMENTS TO MEMORANDUM CIRCULAR NO. 2003-001 DATED JANUARY 7, 2003 BY MEANS OF INCLUSION OF THE WORDS "AND ASIAN UTILITY VEHICLES (AUV's)" IN THE FIRST LINE OF PARAGRAPH NO. 3, AND THE DELETION OF THE WORDS "OTHER THAN AUV," FROM PARAGRAPH NO. 4, FIRST AND SECOND LINES, BOTH FOUND IN THE SAID MEMORANDUM.

Due to the request of transport operators that Asian Utility Vehicles (AUV's) be authorized to be used as Tourist Coupon Taxi Service and Tourist Chartered Service found in Memorandum Circular No. 2003-001, dated January 7, 2003, the words "AND ASIAN UTILITY VEHICLES (AUV's)" is deemed included and inserted between the words "vehicles" and "with" found in the first line of paragraph no. 3 of said Memorandum Circular, which is now to be read as follows:

"3. Tourist Coupon Taxi Service: refers to 4-door sedan vehicles and asian utility vehicles (AUV's) with concessionaire agreement, plying the international and/or domestic airports, seaports and hotels covered with tourist coupon taxi service franchise which fare charges are predetermined by the Board, requiring minimum of ten (10) units, at maximum age limit of 10 years from date of manufacture."

Likewise, the words "OTHER THAN AUV" as found in paragraph no. 4, first and second lines, of the same Memorandum Circular is DELETED, which is now to be read as follows:

"4. Tourist Chartered Service: refers to bus, coaster, van and 4-door sedan vehicles catering to tourists covered with tourist chartered service franchise which fare charges

are predetermined by the Board, requiring minimum of three (3) units, at maximum age limit of 15 years for bus and coaster and 10 years for van and car, from date of manufacture."




