



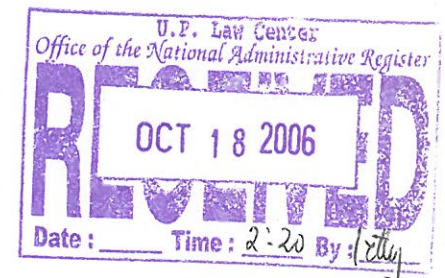

MEMORANDUM CIRCULAR

SUBJECT: LIFTING OF MORATORIUM ON THE ACCEPTANCE OF APPLICATION FOR FILCAB (Mini-Jitney) SERVICE ON DEVELOPMENTAL ROUTES IN REGION VIII

After a careful study and actual inspection of various routes in Region VIII, and having found that there is no unit operating thus, a vacuum of appropriate mode of transport service, the Board in the interest of public service, hereby declares the acceptance of new applications for Filcab (Mini-Jitney) service on the following developmental routes in Region VIII.

Each route shall only accept a maximum of fifteen (15) units unless it is so indispensable and necessary to serve and promote public interest, in which case it shall not exceed more than twenty (20) units.

All rules and regulations that are inconsistent with the provision of this Memorandum Circular are deemed to have been modified, amended or repealed accordingly.


This Memorandum Circular shall take effect fifteen (15) days following publication in the official gazette or newspaper of general circulation in Region VIII, Eastern Visayas, Philippines.
