MEMORANDUM CIRCULAR
NUMBER 2016 - 017

SUBJECT: ALTERNATIVE ROUTES FOR BUS OWNERS WITH REGARD TO MMDA MEMORANDUM CIRCULAR NO. 21, SERIES OF 2016 ENTITLED "OMNIBUS GUIDELINES ON THE OPERATION OF PROVINCIAL BUSES ALONG EDSA AND THEIR TERMINALS LOCATED THEREAT"

Per Item No. 04 of Metro Manila Development Authority (MMDA) Memorandum Circular No. 21, Series of 2016 entitled "Omnibus Guidelines on the Operation of Provincial Buses along EDSA and their terminals located thereat" which states:

"Provincial buses are not allowed to ply the route from EDSA – Timog Ave, Quezon City to EDSA – P. Tuazon Blvd., Quezon City southbound only from Monday to Friday from 6:00am until 10:00am. These buses shall take the alternate routes as may be allowed by the Land Transportation Franchising and Regulatory Board (LTFRB)."

This Board hereby allows the following Provincial buses to traverse the following routes in travelling to and from their respective bus terminals in EDSA:

North of Aurora Blvd.

From North – Southbound EDSA and Vice Versa: NLEX – A. Bonifacio – C3 (Araneta Ave.) – E. Rodriguez Sr., New York St.

From South – Southbound EDSA and Vice Versa: C5 – Aurora Blvd. – E. Rodriguez Sr. Ave. – New York St.,

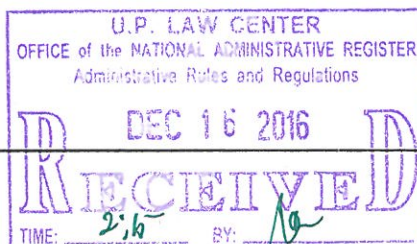
South of Aurora Blvd.

From North – Southbound EDSA and Vice Versa: C5 (use truck lane) – P. Tuazon Blvd., Councilor C. Benitez St.. – Mayor Ignacio Santos Diaz St.

From South – Southbound EDSA and Vice Versa: C5 – U-turn near Monasterio de Sta. Clara – P. Tuazon Blvd. – Councilor C. Benitez St. – Mayor Ignacio Santos Diaz St.

All other issuances or parts thereof inconsistent herewith are hereby modified, amended, or superseded accordingly.

This Memorandum Circular shall take effect immediately following its publication in a newspaper of general circulation and the filing of three (3) copies hereof with the UP Law Center pursuant to Presidential Memorandum Circular No. 11, dated 09 October 1992.
