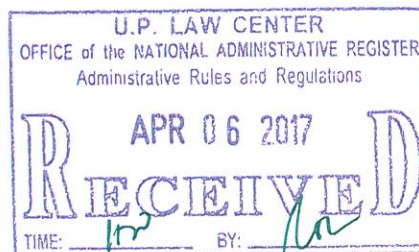
**SUBJECT : CONDITIONAL CONFIRMATION OF UNITS WITH
DISMISSED APPLICATIONS/SUSPENDED OR CANCELLED CPC
WITH TIMELY FILED MOTION FOR RECONSIDERATION AND
REPEAL OF MEMORANDUM CIRCULAR No. 2015-019 (Re: Non-
Confirmation of Units of Dismissed Applications with Prayer
for Extension of Validity)**

On 09 June 2015, the Board issued Memorandum Circular No. 2015-019 (Re: Non-Confirmation of Units of Dismissed Applications with Prayer for Extension of Validity) decreeing that unit/s under a dismissed Application for Extension of Validity shall not be allowed confirmation for the purpose of registration until the said dismissal is lifted and set aside.

After revisiting the said Circular and upon deliberation by the Board, the Board hereby repeals Memorandum Circular No. 2015-019 and hereby decree that unit/s under a dismissed Applications/Suspended or Cancelled CPC may be given conditional confirmation by the Information Systems and Management Division (ISMD) for the purpose of registration provided that a Motion for Reconsideration has been timely filed pursuant to Section 11, Rule 13 of the 2011 Revised Rules of Practice and Procedure before the Land Transportation Franchising and Regulatory Board.

The status of the conditional confirmation provided under this Memorandum Circular shall be subject to cancellation or ratification by the Board after the lapse of Fifteen (15) days from receipt of the Order or Resolution in the pending case. The Order or Resolution shall remain effective even pending appeal unless the Secretary of the Department of Transportation (DOTr) issue a *status quo ante* Order.

All other issuances or parts thereof inconsistent herewith are hereby modified, amended, or superseded accordingly.
