**MEMORANDUM CIRCULAR**  
NUMBER 2017- 018

**SUBJECT: SUPPLEMENT TO MC 2017-013  
(PUBLIC UTILITY DRIVERS ACADEMY PROGRAM)**

WHEREAS, the Board is empowered under Section 5 (k) of Executive Order No. 202 "to formulate, promulgate, administer, implement and enforce rules and regulations on land transportation public utilities... as may promote safety, protection, comfort and convenience to persons and property in their charges as well as the safety of persons and property within their areas of operations;"

WHEREAS, Memorandum Circular No, 2017-013, Re: Public Utility Drivers Academy Program was issued by this Board on June 16, 2017 to improve the behavior and driving skills of PUV drivers and will protect the health, welfare, and promote safety and convenience not only of passengers and pedestrians but also of the public in general;

WHEREAS, the said Memorandum Circular provides that an Identification Card with a Certificate of Completion/Attendance printed at the back and valid for a period of one (1) year shall be issued to drivers/ participants after the program;

WHEREAS, there is a need to cover the expenses for the Identification Cards to be issued to the drivers/participants with corresponding security features;

NOW THEREFORE, the Board, by virtue of the powers vested in it by law, do hereby supplements to MC 2017-013, Re: PUBLIC UTILITY DRIVERS ACADEMY PROGRAM the payment of Php40.00 for the cost of the Identification Cards with security features.

The said Identification Cards should be in a conspicuous place inside the vehicle

All other issuances or parts thereof inconsistent herewith are hereby modified, amended, or superseded accordingly.

This Memorandum Circular shall take effect immediately following its publication in a newspaper of general circulation and the filing of three (3) copies hereof with the UP Law Center pursuant to Presidential Memorandum Circular No. 11, dated 09 October 1992.
