BOARD RESOLUTION NO. 03, Series of 2016
(Re: ACCREDITATION OF PREMIUM POINT-TO-POINT BUS SERVICE)

WHEREAS, the Board issued Memorandum Circular No. 2015-027 (Re: Implementing Guidelines of Department Order No. 2015-018 on the Opening of Premium Point-to-Point Bus Service);

WHEREAS, the Board issued Memorandum Circular No. 2016-001 Amending Memorandum Circular No. 2015-027 (Re: Implementing Guidelines of Department Order No. 2015-018 on the Opening of Premium Point-to-Point Bus Service);

WHEREAS, the Board created a Pre-Qualification Committee for the Accreditation of Premium Point-to-Point Bus Service;

WHEREAS, the following applicants for Premium Point-to-Point Bus Service Program submitted their respective Qualification Documents:

1. LAGUNA STAR BUS TRANSPORTATION SYSTEM
2. CITY BUS, INC.
3. FROELICH TOURS, INC.

WHEREAS, during the opening and evaluation of the Qualification Documents by the Pre-Qualification Committee, with the assistance of the Technical Working Group, and in the presence of observers from the Department of Transportation and Communications and the Office of the Cabinet Secretary, only **FROELICH TOURS, INC.**, was given a rating of **PASSED** or **QUALIFIED** in its Application for Package 4. All others were given a rating of **FAILED** or **NOT QUALIFIED**;

WHEREAS, the Pre-Qualification Committee, in its Resolution dated 10 February 2016, recommended that **FROELICH TOURS, INC.** be directed to inform the Board within forty-eight (48) hours from receipt of the Notice of Selection of its intention to operate an interim service on the routes it applied for based on the specifications and operating conditions set forth under Memorandum Circular No. 2016-001 and to submit its application for the issuance of a Certificate of Public Convenience for Package 4;

NOW , THEREFORE, the Board resolves that the recommendation of the Pre-Qualification Committee be **APPROVED AS IT IS HEREBY APPROVED**. In this connection, the said Committee is hereby ordered to properly notify all the applicants in relation to its evaluation results.
