

RESOLUTION NO. 65 Series of 2017
**(Re: RECONSIDERATION OF UNQUALIFIED PROPONENTS FOR
ADDITIONAL PREMIUM POINT TO POINT SERVICE)**

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

WHEREAS, on the scheduled date provided under Memorandum Circular No. 2017 -001, Re: IMPLEMENTING GUIDELINES ON THE OPENING OF PROPOSED ADDITIONAL PREMIUM POINT-TO-POINT SERVICES, which was amended by Memorandum Circular No. 2017-005, Re: AMENDMENT ON MC 2017-001, or on March 31, 2017 from 9:00 AM to 2:00 PM, the following prospective applicants for Premium Point to Point Service were given a rating of NOT QUALIFIED for failure to comply with the implementing guidelines set forth under MC 2017-001, as amended by MC 2017-007:

1. CITY BUS INC. (PACKAGE 5)
2. GENESIS TRANSPORT, INC. (PACKAGE 1)
3. DE GUIA ENTERPRISES, INC. (PACKAGE 2)
4. SILVERSTAR SHUTTLE & TOURS(PACKAGE 5)
5. PENAFRANCIA TOURS AND TRAVE TRANS., INC. (PACKAGE 4)

WHEREAS, CITY BUS and GENESIS were not qualified as they failed to comply with Item No III Qualification Requirements, No. 2 Technical Qualifications, letter (d) of MC 2017-001, which provides that applicant must submit copies of letter of support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in the route map;

WHEREAS, DE GUIA, SILVERSTAR, and PENAFRANCIA were not qualified for failure to comply with item IV. SUBMISSION OF QUALIFICATION DOCUMENTS of MC 2017-001, which requires applicant to submit one (1) original and two (2) photocopies

WHEREAS, request for reconsideration in the form of letters and Motions were filed by the unqualified proponents GENESIS TRANSPORT, INC. on April 3,

2017, DE GUIA ENTERPRISES, INC. on April 3, 2017, SILVERSTAR SHUTTLE & TOURS, and CITY BUS INC on April 6, 2017;

WHEREAS, the Committee has deliberated on the aforementioned request for reconsideration and revisited the implementing guidelines provided under MC 2017-001 particularly the items thereat subject of the reconsideration;

NOW THEREFORE, the Pre Qualification Committee resolves to as it is hereby resolved the following:

1. **GRANT** the request for reconsideration of CITY BUS, INC. and GENESIS TRANSPORT, INC. as the non compliance with the requirement to submit letter of support was not attributable to the applicants, but due to construction issues of the guidelines set forth thereat, which cause confusion on the period of its submission;
2. **DENY** the request for reconsideration of DE GUIA ENTERPRISES, INC. and SILVERSTAR SHUTTLE AND TOURS, as the guidelines is clear and explicit that applicants shall submit one (1) original copy and two (2) photocopies of the qualification documents; and
3. For the Technical Working Group to proceed with the evaluation of qualification documents of CITY BUS, INC. and GENESIS TRANSPORT, INC.
