BOARD RESOLUTION No. 06
Series of 2017

WHEREAS, On 14 June 2017 at KM21, Crossing Mahayag, Tibungco, Davao City at around 5:00 a.m. a tragic vehicular accident transpired involving an Isuzu Forward Dropside being driven by Juanito B. Labrigas and a Toyota Hi-Ace Commuter Van driven by Joey Alcazaren which resulted in physical injuries to the driver and passenger of the Isuzu Forward Dropside and multiple deaths to the driver and passengers of the Toyota Hi-Ace Commuter Van while several were injured;

WHEREAS, A few days ago, another tragic accident occurred in the National Highway along Pantukan, Compostela Valley, resulting to multiple injuries to the passengers;

WHEREAS, Various reports have reached the attention of the Board that the UV Express vans plying the northern route of Davao City, were engaged in reckless driving and over speeding, endangering the lives and limbs of the commuting public. Records reveal that four (4) vehicular accidents involving UV Express vans have occurred in Region 11 from October 2016 to March 2017;

WHEREAS, Acting on the above serious tragic accidents, the Board in the interest of the safety and general welfare of the riding public, calls on the Local Government Units (LGUs) to heed the call and encourage their constituents to take Public Utility Buses in light of these dangerous accidents resulting to tragic loss of lives and injuries to many;

NOW THEREFORE, the Board hereby resolves to **ORDER** all operators of UV Express Service with routes going to and from Davao City going North including but not limited to Davao Oriental, Tagum/Mati and Compostela Valley and beyond to **CEASE** and **DESIST** from operating their authorized units until further notice from the Board and pending serious and thorough review of their operations and inspection of the PUVs concerned.

The concerned Regional Franchising and Regulatory Offices (RFROs) are directed to coordinate with the City of Davao and other local government units affected for the proper implementation of this Resolution. Any UV Express Operators violating this Resolution shall be dealt with accordingly and when warranted, be imposed with the proper penalties.

This Board Resolution takes effect immediately.


