RESOLUTION NO. _006 _ Series of 2018
(Re: ADDITIONAL PREMIUM POINT-TO-POINT SERVICE UNDER MC 2017-025)

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Pre-Qualification Committee for the Accreditation of Premium Point-to-Point Bus Service;

WHEREAS, in the previous Board Resolution issued by this Committee relative to the COMPLIANCE OF GENESIS TRANSPORT SERVICE, INC. and RECONSIDERATION OF VICTORY LINER, INC. FOR ADDITIONAL PREMIUM POINT-TO-POINT BUS SERVICE, it resolved to:

1. **CONSIDER** the Compliance and Manifestation of GENESIS TRANSPORT SERVICE, INC. to be in accordance with the requirement of the committee, including the documents required for submission;
2. **GRANT** the request for reconsideration of VICTORY LINER, INC. as it established sufficiently that its Audited Financial Statement was received by the BIR representative;
3. **DIRECT** the Technical Working Group to proceed with the evaluation of qualification documents of GENESIS TRANSPORT SERVICE, INC. and VICTORY LINER, INC.

WHEREAS, in compliance with the said Board Resolution, the Technical Working Group has evaluated the qualification documents of Genesis Transport Service, Inc. and Victory Liner, Inc. and submitted its abstract report to the Pre-Qualification Committee on January 25, 2017;

WHEREAS, considering that Delta Neosolutions, Inc. failed to timely file its Motion for Reconsideration, the disqualification of Delta Neosolutions, Inc. STANDS.

WHEREAS, the Committee has conducted further evaluation and careful review of the qualification documents submitted by Genesis Transport Service, Inc. and Victory Liner, Inc. vis-à-vis the abstract of the TWG;

NOW THEREFORE, the Pre-Qualification Committee resolves to recommend to the Board the following:

1. **Award** in favor of **GENESIS TRANSPORT SERVICE, INC.** to process further its **Application for PACKAGE 1 (CLARK - LUBAO, PAMPANGA WITH SPECIAL STOPS IN SAN FERNANDO, PAMPANGA AND ANGELES CITY)** of the PREMIUM POINT-TO-POINT BUS SERVICE under MC 2017-025;
2. **Award** in favor of **VICTORY LINER, INC.** to process further its **Application for PACKAGES 2 (CLARK - DAGUPAN, PANGASINAN WITH SPECIAL STOP IN CARMEN, ROSALES) and 3 (CLARK - DAGUPAN, PANGASINAN WITH SPECIAL STOP IN DINALUPIHAN, BATAAN)** of the PREMIUM POINT-TO-POINT BUS SERVICE under MC 2017-025; and
3. To **RE-OPEN** for prospective applicants **ALL OTHER UNFILLED PACKAGES** of PREMIUM POINT-TO-POINT BUS SERVICE under MC 2017-025.
