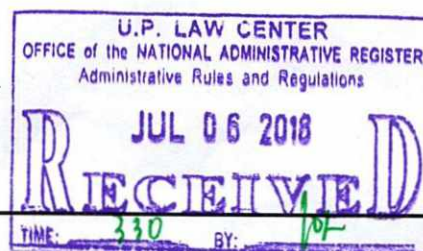
This Board hereby amends and modifies Memorandum Circular No. 2018-013 on the following items:

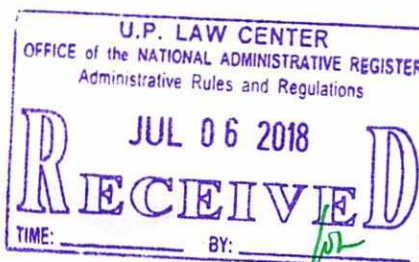
