**RESOLUTION NO. 017 Series of 2019**  
(Re: ACCREDITATION OF TRANZWATCH CORPORATION AS A  
GPS DEVICE PROVIDER)

**WHEREAS**, pursuant to Section 5, Paragraph (k) of Executive Order No. 202 empowering the Board "To formulate, promulgate, administer, implement and enforce rules and regulations on land transportation public utilities, standards of measurements and/or design, and rules and regulations requiring operators of any public land transportation service to equip, install and provide in their stations such devices, equipment facilities and operating procedures and techniques as may promote safety, protection, comfort and convenience to persons and property in their charges as well as the safety of persons and property within their areas of operation."

**WHEREAS**, pursuant to Memorandum Circular No. 2015-013 (Re: Guidelines to Govern the Accreditation of GPS Device Providers) a Pre-Accreditation Committee was created to evaluate all applications for GPS Device Provider accreditation filed before the LTFRB and recommend to the Board its approval and disapproval;

**WHEREAS**, the applicant Tranzwatch Corporation filed its supporting documents for accreditation as a GPS Device Provider on 3 December 2018 as required by the Board in Memorandum Circular Nos. 2015-013 and 2016-016.

**NOW THEREFORE**, premises considered, finding the application of Tranzwatch Corporation complete and compliant with Memorandum Circular Nos. 2015-013 (Item Nos. II, III and IV) and 2016-016, the Committee hereby **DIRECTS** the herein applicant to **CONFORM** its GPS devices to the specifications set forth by the Board in Memorandum Circular No. 2015-013 Item No. I GPS Fleet Management System in coordination with the Department of Science and Technology – Advance Science and Technology Institute (DOST-ASTI) and the LTFRB-ISMD.

The herein applicant shall secure a Certificate of Conformity that its GPS devices are compliant with the specifications stated in the above-mentioned Memorandum Circular signed and issued by the Chief of the Information Systems Management Division.

The recommendation of this Committee to the Board to **GRANT** the application of the herein applicant for a Certificate of Accreditation as a GPS Device Provider shall be issued once its GPS device/s is/are in conformity with the required specifications.
