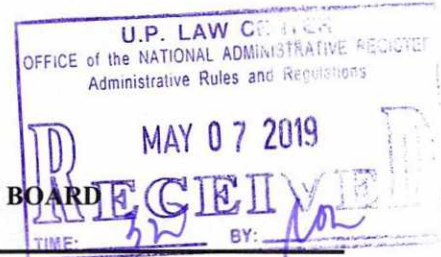

MEMORANDUM CIRCULAR

SUBJECT: OPENING OF APPLICATIONS FOR THE ISSUANCE OF NEW CERTIFICATE OF PUBLIC CONVENIENCE (CPC) UNDER THE INITIAL IMPLEMENTATION OF PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP) AS APPROVED DURING THE 8th LTFRB BOARD MEETING

WHEREAS, on 19 June 2017, the Department of Transportation (DOTr) issued Department Order No. 2017 - 011 also known as the Omnibus Guidelines on the Planning and Identification of the Public Road Transportation Services and Franchise Issuance adopting the rules and procedures for the issuance of the franchises for public transport routes and services;

WHEREAS, pursuant to Section 5(a) of Executive Order No. 202, dated 19 June 1987, the Land Transportation Franchising and Regulatory Board (LTFRB) shall have the power to "prescribe and regulate routes of service, economically viable capacities and zones or areas of operation of public land transportation services provided by motorized vehicles, xxxxx";

WHEREAS, the DOTr has given LTFRB the authority to deliberate and take appropriate action on proposed new/additional routes pursuant to the Public Utility Vehicle Modernization Program (PUVMP) and Memorandum Circular No. 2018-006;

WHEREAS, during the 8th LTFRB Board Meeting held on 25 March 2019, the routes hereunder were approved;

NOW THEREFORE, premises considered, the following routes with corresponding Route Survey Information are hereby approved for the issuance of New CPCs:

Each route will be awarded to only one (1) qualified Applicant and subsequently processed for the grant of CPC following the provisions of Memorandum Circular No. 2019-013 also known as the Consolidated Guidelines on the Process of Issuance of Certificate of Public Convenience (CPC), and Provisional Authority (PA)/Special Permit (SP) under the Omnibus Franchising Guidelines & Public Utility Vehicle Modernization Program (PUVMP) dated 15 March 2019.

The deadline for the submission of Letter of Intent and qualification documents will be at 12:00 noon of 17 May 2019, to be submitted at the concerned LTFRB- RFRO for Intra-regional routes, or at the Office of the Executive Director- Central Office for Metro Manila and Inter-regional routes. Opening of the sealed documents will immediately follow at 1:30pm of the same date.

In case of failure on the initial qualification process, interested applicants shall be given ten (10) working days from 17 May 2019 to file their Letter of Intent and qualification documents.

This Memorandum Circular shall take effect immediately following its publication in a newspaper of general circulation and the filing of three (3) copies hereof with the U.P. Law Center pursuant to Presidential Memorandum Circular No. 11 dated 09 October 1992.




