RESOLUTION NO. 156 Series of 2019
(Re: MOTION FOR CANCELLATION AND MOTION FOR
RECONSIDERATION OF GUARDIAN POLICE BANTAY PAMILYA
TRANSPORT COOPERATIVE)

WHEREAS, Guardian Police Bantay Pamilya Transport Cooperative (Guardian for brevity purposes) was issued with a Notice of Conditional Selection on February 26, 2019 regarding its application for the routes Brgy. Paliparan, Dasmarinas, Cavite to PITX, and Molino, Bacoor, Cavite to PITX to operate Utility Vehicle Express Service pursuant to Memorandum Circular No. 2018-027;

WHEREAS, In the said Notice of Conditional Selection, the Pre-Qualification Committee has given Guardian ninety (90) days from receipt of their Notice to submit documentary requirements stated thereat, and in case of failure to comply within the specified period will automatically nullify and render void *ab initio* the issued Notice;

WHEREAS, compliance thereto was submitted by Guardian on March 27, 2018, which was evaluated by the Committee and found that Certification or Letter of Support from PITX Allowing Guardian to use the same as its terminal was not submitted;

WHEREAS, Resolution No. 087 Series of 2019 was issued by the Pre-Qualification Committee which resolved to recommend to the Board to NULLIFY AND RENDER VOID AB ANITIO the issued Notice of Conditional Selection in favor of Guardian dated February 26, 2019 for failure to comply with the documentary requirements set forth under the said Notice, and Memorandum Circular No. 2018-027, including the Certification or Letter of support to use PITX; and

WHEREAS, Motion for Cancellation and Motion for Reconsideration were filed by Guardians on May 27, 2019 and June 4, 2019, respectively,

WHEREAS, the Board has deliberated on the aforementioned Motions and revisited the implementing guidelines provided under MC 2018-027 particularly the items thereat subject of the request for reconsideration.

NOW THEREFORE, the Pre Qualification Committee resolves to as it is hereby resolved to:

1. **GRANT** the Motion for Reconsideration and Motion for Cancellations of Guardian as it established with merit the allegations contained thereat, and **SET ASIDE** Resolution No. 087 Series of 2019 dated May 15, 2019;

2. **DIRECT** Guardian to submit on or before July 10, 2019 an Undertaking that it will comply with the technical requirement of Certification or Letter of Support from PITX Allowing Guardian to use PITX as its endpoint terminal within the period prescribe hereunder; and
3. For Guardian to submit not later than July 31, 2019 the required Certification or Letter of Support from PITX Allowing Guardian to use PITX as its endpoint terminal, otherwise, this Resolution shall be NULLIFIED and Resolution No. 087 Series of 2019 dated May 15, 2019 shall be REINSTATED;
4. The processing of Application for Issuance of Certificate of Public Convenience to Operate UV Express Service on the routes Brgy. Paliparan, Dasmarinas, Cavite to PITX, and Molino, Bacoor, Cavite to PITX to operate Utility Vehicle Express Service pursuant to Memorandum Circular No. 2018-027 shall be allowed only upon full compliance of the documentary requirements.
