RESOLUTION NO. 159 Series of 2019

(Re: Opening Of Public Utility Vehicle (PUV) Routes For The Paranaque Integrated Terminal Exchange (PITX) And Augmentation Of Existing PUVs Serving The Terminal – Application of Jasper Jean Services, Inc.)

WHEREAS, on 23 January 2019, the Board issued Memorandum Circular No. 2019-005 with subject “Opening Of Public Utility Vehicle (PUV) Routes For The Paranaque Integrated Terminal Exchange (PITX) And Augmentation Of Existing PUVs Serving The Terminal”.

WHEREAS, on 26 February 2019 the Pre-Qualification Committee issued a Notice of Conditional Selection regarding the application of Jasper Jean Services, Inc. for the route PITX - LANCASTER NEW CITY.

WHEREAS, in the said Notice, upon the selection of Jasper Jean Services, Inc. on the above-mentioned route, the applicant was given the condition to submit its proof of garage and terminal for the maximum number of fifteen (15) PUB units within ninety (90) days.

WHEREAS, on 25 March 2019, Jasper Jean Services, Inc. submitted its compliance on the condition in the above-mentioned Notice.

WHEREAS, on 15 May 2019, the Pre-Qualification Committee issued Resolution No. 92 series of 2019 wherein the Committee resolved:

“NOW THEREFORE, this Pre-Qualification Committee resolves to recommend the Board to **NULLIFY AND RENDER VOID AB INITIO** the issued Notice of Conditional Selection dated 26 February 2019 issued to Jasper Jean Services, Inc. for the route PITX - Lancaster New City to operate PUB service for failure to submit a proof of garage and terminal as required under Memorandum Circular No. 2019-005 including the Certification or Letter of Support to use PITX. This is however without prejudice on its part to re-apply or submit application in case the subject route is subsequently re-opened.”

WHEREAS, on 10 June 2019, Jasper Jean Services, Inc. filed a Motion for Reconsideration regarding the issued above-mentioned Resolution wherein Jasper Jean Services, Inc. attached the following documents, to wit:

1. Special Permit dated 31 May 2019 signed by the Board to operate in the PITX - Lancaster New City route with five (5) interim bus units valid up to three (3) months.

2. Table of Contents of the qualification documents regarding Jasper Jean Services, Inc.'s application on the said route received by the Office of the Executive Director on 31 January 2019.
3. Certification from MWM Terminals signed by its General Manager - Mariano Antonio Arroyo, Jr. with Reference No. CERTOPTNS-2019-13 dated 29 January 2019 issued to Jasper Jean Services, Inc., supporting Jasper Jean Services, Inc. its intent to apply for the route PITX - Lancaster New City and has provided slots in the loading and unloading bays of PITX.
4. Certification from PRO-FRIENDS (property developer of Lancaster New City) signed by its Head - Terence R. Crisostomo and Joseph E. Mora dated 30 January 2019 supporting Jasper Jean Services, Inc. to its intent to apply for a CPC on the route PITX - Lancaster New City and granting permission to have a terminal/bus stop to load & unload passengers.
5. Affidavit of Support signed by Edwin P. Costes owner of the parcel of land located at Caridad Extention, Cavite City, with a total area of 573 sqm under TCT # T-24309.
6. Photocopy of Transfer Certificate of Title registered under the name of Edwin P. Costes with TCT # T-24309.
7. Affidavit of Support signed by Ariel A. Bocolan owner of the parcel of land located at Lot 1706-A-1-A Subdivision Barrio Navarro, General Trias, Cavite with a total area of 3,067 sqm under TCT # 057-2013006556.
8. Photocopy of Transfer Certificate of Title registered under the names of spouses Ariel A. Bocolan and Ma. Gracielle I. Bocolan with TCT # 057-2013006556.

NOW THEREFORE, premises considered, appearing that the filed Motion for Reconsideration and attached documents is meritorious, the Committee resolves to **LIFT AND SET-ASIDE** the issued Resolution No. 92 series of 2019 and further recommend to the Board to **RE-AWARD** the PITX - Lancaster New City route in favor of **Jasper Jean Services, Inc.**
