2. Deed of Sale executed by Eduardo L. Santos and Sps. Augusto B. Bao-Idang & Analyn G. Bao-Idang to support the attached Transfer Certificate of Title numbered 009-2014007291 and the undated Letter of Support signed by Augusto B. Bao-idang re: Copies of Letter of Support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in the route map;
3. Proof of financial capability of at least equal to the set-aside bank deposit, duly certified by the depository bank, which is equivalent to fifty thousand pesos (Php 50,000.00) for UV Express services per unit, multiplied by the total number of vehicles for the route that the Applicant-Operator is applying for.

NOW THEREFORE, premises considered, the Committee resolves to recommend to the Board to **DENY** the aforesaid application.
