**RESOLUTION NO. 192 Series of 2019**

(Re: Opening of Applications for the Issuance of New CPC under the PUVMP as approved during the 11th LTFRB Board Meeting – Application of METRO COMET TRANSPORT SERVICE COOP.)

**WHEREAS**, on 15 March 2019, this Board issued Memorandum Circular No. 2019-013 to implement the consolidated guidelines on the process of Issuance of Certificate of Public Convenience (CPC) and Provisional Authority (PA)/Special Permit (SP) under the Omnibus Franchising Guidelines & Public Utility Vehicle Modernization Program (PUVMP);

**WHEREAS**, on 14 May 2019, this Board issued Memorandum Circular No. 2019-024 for the opening of a new/developmental/inter-regional route RODRIGUEZ - MARIKINA (BFCT EAST TERMINAL AND SM MARIKINA) relative to the implementation of the Public Utility Vehicle Modernization Program;

**WHEREAS**, on 3 July 2019, the 3rd Qualification Committee (created by the Board which issued LTFRB Office Order No. 2019-114 pursuant to Memorandum Circular No. 2019-013) issued Resolution numbered 141 series of 2019 wherein the Committee resolved:

**“NOW THEREFORE**, premises considered and after rating the qualification documents submitted as **PASSED/QUALIFIED**, the Committee resolves to recommend to the Board to **AWARD** the RODRIGUEZ – MARIKINA (BFCT EAST TERMINAL AND SM MARIKINA) route in favor of **METRO COMET TRANSPORT SERVICE COOP.**”

**NOW THEREFORE**, for and in consideration of the foregoing premises, this Board hereby **ADOPTS** the recommendation of the 3rd Qualification Committee, let the **RODRIGUEZ – MARIKINA (BFCT EAST TERMINAL AND SM MARIKINA)** route be **AWARDED** and a Notice of Selection be **ISSUED** to **METRO COMET TRANSPORT SERVICE COOP.**
