RESOLUTION NO. 205 Series of 2019

(Re: Opening of Applications for the issuance of New CPC under the initial implementation of the PUVMP approved during the 15th Board Meeting – Application of VICTORY LINER, INC., G.V. FLORIDA TRANSPORT INC. & FIRST NORTH LUZON TRANSIT, INC. on the route TUGUEGARAO CITY, CAGAYAN - MARIVELES, BATAAN)

WHEREAS, before this Committee is the application of VICTORY LINER, INC., G.V. FLORIDA TRANSPORT INC. & FIRST NORTH LUZON TRANSIT, INC. for TUGUEGARAO CITY, CAGAYAN - MARIVELES, BATAAN route under Memorandum Circular No. 2019-027.

WHEREAS, VICTORY LINER, INC., G.V. FLORIDA TRANSPORT INC. & FIRST NORTH LUZON TRANSIT, INC. were given a rating of **QUALIFIED** as they fully complied with the Qualification Requirements - Legal, Technical and Financial Capability Qualifications provided under Memorandum Circular No. 2019-013;

WHEREAS, three (3) copies of the LTO Certificate of Registration and Official Receipt with Plate Nos. CAY-4573, CAY-4562 and CAY-3377 out of the fourteen (14) units submitted/provided by VICTORY LINER, INC. are not signed/truly certified;

WHEREAS, on 8 July 2019, VICTORY LINER, INC. submitted a letter with the subject "Clarifications Re: Victory Liner, Inc.'s bid for Item 2 under Memorandum Circular 2019-027" wherein VICTORY LINER, INC. stated thus:

"However, through mere inadvertence, the Records Officer of the Land Transportation Office in Olongapo City failed to place the stamp, 'EVA P. PILIEN RECORDS SECTION LTO OLONGAPO', and affix her signature on the certified true copies of the ORs and CRs of the bus units stated below:

with attached certified true copies of the subject units' LTO ORs/CRs and notarized affidavit signed by Eva P. Pilien - Records Officer in LTO Olongapo City;

WHEREAS, this Committee is only limited to check/evaluate the documentary requirements submitted/provided within the sealed box or envelope by an applicant-operator (i.e. VICTORY LINER, INC.), hence, the clarifications made will not affect the recommendation made by this Committee to the Board;

WHEREAS, a notarized Certificate and Declaration of Undertaking signed by John Edward P. Hernandez - Vice President for Operations of Victory Liner, Inc. was submitted/provided wherein the affiant certified that the remaining one (1) unit (Volvo B8R Euro 5 Bus) will be delivered within sixty (60) days from the proforma invoice dated 28 June 2019, as stated in the Certificate of Delivery Schedule issued by the supplier (Autodelta Coach Builders, Inc.);

WHEREAS, G.V. FLORIDA TRANSPORT INC. & FIRST NORTH LUZON TRANSIT, INC. submitted their undertaking that 25% of the number of required units within three (3) months, 50% within six (6) months, 100% within nine (9) months will be delivered by the vehicle manufacturer/supplier since no compliant units are available as of the time of the proceedings, hence, VICTORY LINER, INC. is the most **QUALIFIED** because of its eleven (11) provincial bus units that are **READY AND AVAILABLE** as shown in the submitted certified true copies of LTO Certificates of Registration and Official Receipts including the remaining one (1) unit with undertaking;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to **AWARD** the TUGUEGARAO CITY, CAGAYAN - MARIVELES, BATAAN route in favor of **VICTORY LINER, INC.**
