RESOLUTION NO. 207 Series of 2019

(Re: Opening Of Applications For The Issuance Of New CPC Under The Initial Implementation Of The PUVMP Approved During 12th Board Meeting – Application of PARTAS TRANSPORTATION COMPANY, INC. on the BAGGAO, CAGAYAN - PAOAY, ILOCOS NORTE route)

WHEREAS, before this Committee is the application of PARTAS TRANSPORTATION COMPANY, INC. for the BAGGAO, CAGAYAN - PAOAY, ILOCOS NORTE route under Memorandum Circular No. 2019-026.

WHEREAS, after a careful and thorough evaluation of the above application and its supporting documents, the Committee found that the applicant failed to submit/provide the following, to wit:

1. Undertaking that the applicant will immediately comply with the approved DOTr rationalization study or LPTRP;
2. Undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS (submitted document was signed by the manufacturer/supplier of the units, not by the applicant);

WHEREAS, the applicant submitted/provided undertakings in lieu of the following documentary requirements set forth under the Technical Qualifications of Memorandum Circular No. 2019-013, to wit:

1. Undertaking signed by the President of Partas to secure evidence of formal arrangement with Automatic Fare Collection (AFC) service provider that will offer inter-operable AFC service that is fully compliant with fare media related technical specifications as determined by LTFRB;
2. Undertaking to secure copies of Letter of Support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in both endpoints.

WHEREAS, as per Item No. III Applicant-Operator Qualification Requirements under Memorandum Circular No. 2019-013, all applicant-operators shall pass the minimum qualifications listed under Section III-B (Technical Qualifications);

WHEREAS, upon careful review of Memorandum Circular No. 2019-013, submission of an “undertaking” instead of the actual documentary requirements can be a ground for the applicant-operator to be rated as “FAILED”;

NOW THEREFORE, premises considered, the Committee resolves to recommend to the Board to **DENY** the aforesaid application.
