MEMORANDUM CIRCULAR
NUMBER 2019- 043

SUBJECT: OPENING OF APPLICATIONS FOR THE ISSUANCE OF NEW CERTIFICATE OF PUBLIC CONVENIENCE (CPC) UNDER THE INITIAL IMPLEMENTATION OF THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM APPROVED DURING 16th BOARD MEETING

WHEREAS, on 19 June 2017, the Department of Transportation (DOTr) issued Department Order No. 2017-011 (Re: Omnibus Guidelines on the Planning and Identification of the Public Road Transportation Services and Franchise Issuance) adopting the rules and procedures for the issuance of franchises for public transport routes and services;

WHEREAS, pursuant to Section 5(a) of Executive Order No. 202, dated June 19, 1987, the Land Transportation Franchising and Regulatory Board (LTFRB) shall have the power “to prescribe and regulate routes of service, economically viable capacities and zones or areas of operation of public land transportation services provided by motorized vehicles, xxxxx”;

WHEREAS, the DOTr has given LTFRB the authority to deliberate and take appropriate action on proposed new/ additional routes pursuant to Public Utility Vehicle Modernization Program (PUVMP) and Memorandum Circular No. 2018-006;

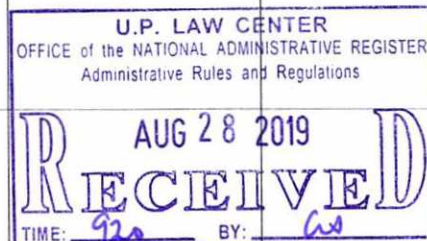

Pre- Qualification Conferences shall be held at concerned Regions and at the Central Office (for inter-regional route) on **August 29, 2019, 2:00 p.m.**

The deadline for the submission of Letter of Intent and qualification documents will be at **9:00 am of 13 September 2019** to be submitted at the concerned LTFRB-RFRO for Intra-regional routes, or at the Office of the Executive Director-Central Office for Metro Manila and Inter-regional routes. Opening of the sealed documents will immediately follow at **10:00 am of the same date.**

In case of failure on the initial qualification process, interested applicants shall be given ten (10) working days reckoned from the date when the initial qualification has been declared a failure to file their Letter of intent and qualification documents.

Opening of the sealed documents will immediately follow at 10:00 am of the same date.

In case of failure on the initial qualification process, interested applicants shall be given ten (10) working days reckoned from the date when the initial qualification has been declared a failure to file their Letter of intent and qualification documents.

This Memorandum Circular shall take effect immediately following its publication in a newspaper of general circulation and the filing of three (3) copies hereof with the UP Law Center pursuant to Presidential Memorandum Circular No. 11, dated 09 October 1992.
