RESOLUTION NO. 224 Series of 2019

Re: Memorandum Circular No. 2019-039: Opening of Applications for the Issuance of New Certificate of Public Convenience (CPC) under the initial implementation of the Public Utility Vehicle Modernization Program approved during the 18th Board Meeting – applications on the route: MCKINLEY, TAGUIG - ROSARIO PASIG)

WHEREAS, before this Committee are the applications of the following, to wit:

1. MCKINLEY TAGUIG PASIG ROSARIO ANTIPOLO TRANSPORT COOPERATIVE
2. I-SHALOM CORP.

for the MCKINLEY, TAGUIG - ROSARIO PASIG route with the use of fifteen (15) authorized Class 3 UV units, under the initial qualification process on 27 August 2019 pursuant to Memorandum Circular No. 2019-039;

WHEREAS, MCKINLEY TAGUIG PASIG ROSARIO ANTIPOLO TRANSPORT COOPERATIVE failed to submit/provide its Original copy of latest General Information Sheet duly received/issued by the Securities and Exchange Commission and all documentary requirements set forth under the Technical and Financial Capability requirements set forth under Memorandum Circular No. 2019-013;

WHEREAS, the box containing the qualification documents submitted by I-SHALOM CORP. is not appropriately sealed, a violation to Section V-A-1 under Memorandum Circular No. 2019-013 which stated thus: *“The Applicant-Operator shall submit to the concerned Qualification Committee, a letter of intent including its qualification documents (per Section III hereof) which are to be submitted in the following manner: one (1) original copy and four (4) photocopies containing a Table of Contents and bound together in ring binders or folders SEALED in an envelope or a box and appropriately addressed and marked;”*

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **DENY** the application of MCKINLEY TAGUIG PASIG ROSARIO ANTIPOLO TRANSPORT COOPERATIVE for failing to comply with the provisions set forth under Memorandum Circular No. 2019-013;
2. **DENY** the application of I-SHALOM CORP.
