**RESOLUTION NO. 237 Series of 2019**

(Re: RE-OPENING OF PUBLIC UTILITY VEHICLE ROUTES for the Parañaque Integrated Terminal Exchange (PITX) and augmentation of existing PUVs serving the terminal – applications on the route: PITX - ALFONSO/MENDES)

**WHEREAS**, before this Committee are the applications of ACB TRANSPORT SERVICES, INC. for PITX - ALFONSO/MENDES route with the use of twenty-eight (28) authorized PUB units, under the selection/qualification process on 9 September 2019 pursuant to Resolution No. 218 series of 2019;

**WHEREAS**, the Committee found that ACB TRANSPORT SERVICES, INC. failed to submit/provide the following documentary requirements set forth under Memorandum Circular No. 2019-013, to wit:

1. Undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS;
2. Undertaking that the applicant will immediately comply with the approved LPTRP/DOTr rationalization study;
3. Fleet Management System with organized vehicle dispatch procedures;
4. Evidence of formal arrangement with Automatic Fare Collection (AFC) service provider that will offer inter-operable AFC service that is fully compliant with fare media related technical specifications
5. Proof of financial capability of at least equal to the set-aside bank deposit, duly certified by the depository bank, which is equivalent to one hundred thousand pesos (Php 100,000.00) for PUB services per unit.

**WHEREAS**, there was only one applicant who submitted a letter of intent on the said route;

**NOW THEREFORE**, premises considered, this Committee resolves to DIRECT applicant ACB TRANSPORT SERVICES, INC. to SUBMIT within fifteen (15) days from receipt of this Resolution the above-mentioned documentary requirements set forth under Memorandum Circular No. 2019-013. Failure to comply within the period specified herein shall cause the dismissal of the application.
