RESOLUTION NO. 247 Series of 2019
(Re: ACCREDITATION OF IHITCHONLINE
AS TRANSPORTATION NETWORK COMPANY)

WHEREAS, On July 9, 2018, the Committee issued Resolution No. 079 Series of 2018 wherein the committee resolved to deny the Motion for Extension of Time to Comply filed by IHITCHONLINE INC. (petitioner) for failure to state any reason for the requested extension and its Petition for Accreditation as a Transportation Network Company (TNC) for failure to submit/comply within the period specified in Resolution No. 038 Series of 2018;

WHEREAS, Motion for Reconsideration was filed by petitioner on April 12, 2019 raising the following arguments:

1. The petitioner only had due notice of the assailed Resolution on March 28, 2019;
2. The reason for the delay for completion of documents were beyond Petitioner's control as it would be close to impossible to comply within ten (10) days all the findings of the Committee as regards the lacking requirements given the processing period with the BIR and BPLO and the process to amend and complete the procedure with the SEC;
3. Failure to give due course to the Petitioner will result to unjustifiable prejudice and suffering, not just to petitioner, but the riding public as well;
4. Petitioner has exerted beyond reasonable efforts in complying with the directives of the LTFRB; and
5. Petitioner's failure to receive said notice amounts to deprivation of due process.

WHEREAS, finding the above arguments raised in the Motion to be with merit and supported by evidence, this committee is well convinced to grant the said Motion;

NOW THEREFORE, the Pre Qualification Committee resolves, as it hereby resolved to:

1. **GRANT** the Motion for Reconsideration as it established with merit the allegations contained thereat, **SETTING ASIDE** Resolution No. 079 Series of 2018 dated September 28, 2018, and

2. For the applicant to submit Formal Offer of Evidence containing therein the requirements set forth under **Department Order 2015-011**, Re: FURTHER AMENDING DEPARTMENT ORDER NO. 97- 1097 TO PROMOTE MOBILITY and **Memorandum Circular No 2015-015**, Re: RULES AND REGULATIONS TO GOVERN THE ACCREDITATION OF TRANSPORTATION NETWORK COMPANIES, within **Ten (10) days** from receipt hereof without any extension;
