RESOLUTION NO. 249 Series of 2019
**(Re: ACCREDITATION OF MOBER TECHNOLOGY PTE, INC. AS
TRANSPORTATION NETWORK COMPANY)**

WHEREAS, On July 9, 2018, the Committee issued Resolution No. 058 Series of 2018 wherein the committee resolved to deny the Petition for Accreditation as a Transportation Network Company (TNC) filed by Mober Technology PTE Inc.. (applicant) for failure to comply with item (b) of Resolution No. 036 Series of 2018;

WHEREAS, the denial of the said Application was premise on the ground that in the cover letter of the documents for compliance submitted by herein applicant, it stated that applicant have not submitted any Application for Accreditation and only comply with all the requirements list on the Receiving Copy from the attached documentation provided by the LTFRB in violation of MC 2015-015;

WHEREAS, Motion for Reconsideration was filed by applicant on 9 July 2019, alleging among others that its re-filing of the Application on 25 April 2018 cured any formal defects in its application, thus, implores this Honorable Office to admit the re-filed Application and apply the liberality in the application of its rules;

WHEREAS, Memorandum Circular No. 2018-016 entitled "Suspension of Acceptance of New Application for Transport Network Company Accreditation for TNVS" provides that, "all Applicants with Applications for TNC Accreditation pending before the Pre-Accreditation Committee are hereby directed to Submit their complete and compliant requirements within 10 days from receipt or on August 5, 2018 whichever is later, otherwise, their applications shall be Denied by the Committee";

NOW THEREFORE, finding the allegations contained thereat to be impressed with merit and supported by evidence particularly for having filed the proper Application prior to the deadline set by the Board, the Pre-Qualification Committee resolves, as it hereby resolved to:

1. **GRANT** the Motion for Reconsideration as it established with merit the allegations contained thereat, and **SET ASIDE** Resolution No. 058 Series of 2018 dated July 9, 2018, and
2. For the applicant to submit Formal Offer of Evidence containing therein the requirements set forth under Department Order 2015-011, Re: FURTHER AMENDING DEPARTMENT ORDER NO. 97- 1097 TO PROMOTE MOBILITY and Memorandum Circular No 2015-015, Re: RULES AND REGULATIONS TO GOVERN THE ACCREDITATION OF TRANSPORTATION NETWORK COMPANIES within the period of Ten(10) days without any extension;
