**RESOLUTION NO. 255 Series of 2019**

(Re: Premium Point-to-Point Service System Routes Originating From The Philippine Arena In Bocaue, Bulacan – Applications on the route: PHILIPPINE ARENA - CALUMPIT, BULACAN with Special Stops in Bocaue)

**WHEREAS**, on 18 September 2019, the Board issued Memorandum Circular No. 2019-049 also known as the “Premium Point-to-Point Service System Routes Originating From The Philippine Arena In Bocaue, Bulacan”;

**WHEREAS**, the selection process and the grant of CPC for the qualified applicant of a Package follows the provisions of Memorandum Circular No. 2019-013 also known as the Consolidated Guidelines on the Process of Issuance of Certificate of Public Convenience (CPC) and Provisional Authority (PA)/Special Permit (SP) under the Omnibus Franchising Guidelines & Public Utility Vehicle Modernization Program (PUVMP) dated 15 March 2019;

**WHEREAS**, before this Committee is the lone applicant METRO MANILA NORTH TRANSPORT CORP. for the route PHILIPPINE ARENA - CALUMPIT, BULACAN with Special Stops in Bocaue route with the use of fifteen (15) authorized Premium Point-to-Point Bus Service units, under the qualification process on 25 September 2019 pursuant to Memorandum Circular No. 2019-049;

**WHEREAS**, during the proceedings and after due evaluation, the Committee found the application of METRO MANILA NORTH TRANSPORT CORP. to be compliant with the Legal, Technical and Financial Capability Qualifications pursuant to Memorandum Circular No. 2019-013;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to **AWARD** the Philippine Arena – Monumento, Quezon City route in favour of METRO MANILA NORTH TRANSPORT CORP, and to proceed with the filing of application for issuance of Certificate of Public Convenience.


