**RESOLUTION NO. 296 Series of 2019**

 DAVAO CITY - VERUELA, AGUSAN DEL SUR)

**WHEREAS**, the Board issued Memorandum Circular No. 2019-023 wherein the following routes were opened for prospective applicants per recommendation of the concerned RFRO and PUVMP-PMO, to wit:

**WHEREAS**, relative to the application of Golden Valley Bus Line Corp. for the routes DAVAO CITY - LORETO, AGUSAN DEL SUR and DAVAO CITY - ARAKAN, NORTH COTABATO VIA KIDAPAWAN CITY, the Committee issued its Resolution No. 167 series of 2019 dated 10 July 2019 wherein the Committee recommended to the Board to deny its application for the subject routes;

**WHEREAS**, relative to the application of Bachelor Express, Inc. for the route DAVAO CITY - LORETO, AGUSAN DEL SUR, the Committee issued its Resolution No. 152 series of 2019 dated 3 July 2019 wherein the Committee resolved to grant its intent to withdraw its application for the route which the same was hereby withdrawn;

**WHEREAS**, relative to the application of Mindanao Star Bus Transit, Inc. for the route DAVAO CITY - ARAKAN, NORTH COTABATO VIA KIDAPAWAN CITY, the Committee issued its Resolution No. 153 series of 2019 dated 3 July 2019 wherein the Committee resolved to grant its intent to withdraw its application for the route which the same was hereby withdrawn;

**WHEREAS**, after a careful and thorough evaluation of the application of Davao Metro Shuttle Corp. for the routes DAVAO CITY - LORETO, AGUSAN DEL SUR, DAVAO CITY - ARAKAN, NORTH COTABATO VIA KIDAPAWAN CITY and DAVAO CITY - VERUELA, AGUSAN DEL SUR and its supporting documents on 13 June 2019, the Committee found that the applicant is complete and compliant with the requirements set forth under Memorandum Circular No. 2019-013;


