RESOLUTION NO. 303 Series of 2019

(Re: Application of GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE on the route BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027)

WHEREAS, on 9 September 2019, GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE filed its letter of intent and qualification documents to apply for the route BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027 with the use of fifty-five (55) UV units and the selection proceedings were thereafter conducted on 17 October 2019;

WHEREAS, GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE submitted fifty-five (55) copies of Management Agreement with attached LTO Certificate of Registration and Official Receipts for interim use;

WHEREAS, GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE failed to submit/provide its undertaking that 25%, 50% and 100% of the number of required/proposed units will be delivered within three (3), six (6) and nine (9) months respectively;

WHEREAS, GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE provided/submitted a copy of its Certification from HINO Carmona dated 6 September 2019 signed by its President - Michael V. Lomeda certifying the applicant's purchase of eighty-two (82) Class III Type Jeepney to HINO Carmona but no specified period or date is indicated;

WHEREAS, GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE has complied with the Legal and Financial Capability Qualifications set forth under Memorandum Circular No. 2019-013;

NOW THEREFORE, premises considered, this Committee resolves to DIRECT GOLDEN TRANSPORT SERVICE & MULTI-PURPOSE COOPERATIVE to SUBMIT within fifteen (15) days from receipt of this resolution *undertaking that 25%, 50% and 100% of the number of required/proposed units will be delivered within three (3), six (6) and nine (9) months respectively as certified by the vehicle manufacturer/supplier.* Failure to comply within the period specified herein shall cause the dismissal of the application.
