**RESOLUTION NO. 305 Series of 2019**

(Re: Application of BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE on the route BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027)

**WHEREAS**, on 27 August 2019, BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE filed its letter of intent and qualification documents to apply for the BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO route under Memorandum Circular No. 2018-027 with the use of thirty (30) UV units and the selection proceedings was thereafter conducted on 17 October 2019;

**WHEREAS**, BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE has complied with the Legal Qualifications set forth under Memorandum Circular No. 2019-013;

**WHEREAS**, BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE submitted its duly signed and notarized Affidavit of Undertaking to comply with the delivery of compliant units dated 27 August 2019 following the delivery of 25%, 50% and 100% of the number of required compliant units within three (3), six (6) and nine (9) months respectively;

**WHEREAS**, BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE submitted its Certificate of Compliance and Certificate of Allocation from Isuzu Cavite dated 5 July 2019 signed by its Sales Manager - Ino Luna to certify that the modern jeepney units to be released to Barangay Paliparan 3 Transport Coop. adhere to the Public Utility Vehicle standards and specifications set by the DOTr and LTFRB's Omnibus Franchising Guidelines and DTI-PNS and for the allocation of thirty (30) units of 2019 QKR77 Modernized Jeepney Almazora Class 3 will be delivered three (3) months upon receiving the Letter of Guarantee;

**WHEREAS**, BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE failed to submit/provide its undertaking to immediately comply with the approved LPTRP or DOTr rationalization study which a requirement under the Technical Qualifications of Memorandum Circular No. 2019-013;

**NOW THEREFORE**, premises considered, this Committee resolves to DIRECT BARANGAY PALIPARAN 3 TRANSPORT COOPERATIVE to SUBMIT within fifteen (15) days from receipt of this resolution its *undertaking to immediately comply with the approved LPTRP or DOTr rationalization study*. Failure to comply within the period specified herein shall cause the dismissal of the application.
