RESOLUTION NO. 306 Series of 2019

(Re: Application of Shanhai Transport, Inc. on the route MOLINO, BACOR, CAVITE TO PITX under Memorandum Circular No. 2018-027)

WHEREAS, on 19 July 2019, Shanhai Transport, Inc. filed its letter of intent and qualification documents to apply for the route MOLINO, BACOR, CAVITE TO PITX under Memorandum Circular No. 2018-027 with the use of fifteen (15) UV units and the selection proceedings was thereafter conducted on 22 October 2019;

WHEREAS, Shanhai Transport, Inc. has complied with the Legal Qualifications set forth under Memorandum Circular No. 2019-013;

WHEREAS, Shanhai Transport, Inc. submitted seven (7) LTO Certificate of Registration and Official Receipts with MV File Nos./Plate Nos. 1301-1065580/NBM-7498, 1301-1032886, 1301-1065563, 1301-1065559/NBM-7495, 1301-1065555/NBM-7494, 1301-1065574/NBM-7497 and 1301-1032882 with 2018 as its year model, under the name of the corporation's President - Tony Santos Cano; one (1) LTO Certificate of Registration and Official Receipt with MV File No. 1301-1017779 with 2018 as its year model, under the name of the corporation's Secretary - Jeffrey U. Cano with attached BDO Certification signed by the bank's managers Lucy W. Chua and Brian M. Flores dated 12 February 2018; three (3) LTO Certificate of Registration and Official Receipts with MV File Nos./Plate Nos. 1303-566454, 1301-1032873, 1301-1032867 with 2018 as its year model, under the name of the corporation's President - Tony S. Cano with attached BDO Certifications signed by the bank's managers Lucy W. Chua and Brian M. Flores dated 19 February 2018;

WHEREAS, Shanhai Transport, Inc. submitted four (4) proforma invoice with Invoice Nos. GDGM-2019001, GDGM-2019002, GDGM-2019003 and GDGM-2019004 and chassis nos. LL3AAADC9JA030131, LL3AAADC9JA030128, LL3AAADC3JA030125 and LL3AAADC6JA030135 with year models of 2018; also submitted a notarized but unsigned (by the affiant) sworn undertaking dated 16 July 2019 that the remaining four (4) units will be made available within three (3) months with attached letter-certification from Golden Dragon Global Motors, Inc. dated 29 June 2019;

WHEREAS, Shanhai Transport, Inc. submitted a duly signed and notarized Contract of Lease by and between Mr. Claro S. Galingaga, owner of the parcel of land subject for leasing, located at Blk. 45 Lot 20, Platinum, San Nicolas 3, Bacoor, Cavite City, as LESSOR and Shanhai Transport, Inc. referred to as the LESSEE dated 17 July 2019, with attached Transfer Certificate of Title No. T-927845 which the subject land has a 296 sqm in size; also submitted is its signed and notarized Sworn Undertaking dated 19 July 2019 that the Shanhai Transport, Inc. undertake *'to have a compliant garage with zoning clearance upon passing the Qualification Documents which is to be submitted on or before the issuance of Provisional Authority for the proposed units'*;

WHEREAS, on 26 July 2019, the DOTr issued its Memorandum relative to the utilization of government facilities as land transport terminals signed by OIC-Undersecretary Mr. Mark Richmond M. De Leon, wherein the directive to remove the Letter of Support from a government facility being proposed as a public utility vehicle (PUV) terminal as a requirement at the time of application for PUV routes as a requirement for the applicant/bidder of PUV routes under Memorandum Circular No. 2019-013, hence, a letter of support from a government facility such as PITX is no longer a requirement;

WHEREAS, Shanghai Transport, Inc. has complied with the Financial Capability Qualifications set forth under Memorandum Circular No. 2019-013;

NOW THEREFORE, premises considered, this Committee resolves to DIRECT Shanghai Transport, Inc. to SUBMIT within fifteen (15) days from receipt of this resolution *duly signed and notarized sworn undertaking that the remaining four (4) units will be made available within three (3) months*. Failure to comply within the period specified herein shall cause the dismissal of the application.
