RESOLUTION NO. 312 Series of 2019

(Re: Opening of Additional Taxi Franchise for Metro Manila including MUCEP Area – Application of AGRIPINA R. MENDOZA)

WHEREAS, on 19 December 2018, the Board issued Memorandum Circular No. 2018-026 also known as the “Opening of Additional Taxi Franchise for Metro Manila including MUCEP Area” to hereby OPEN additional air-conditioned taxi franchise for five thousand (5,000) units for Metro Manila including the MUCEP area;

WHEREAS, on 23 September 2019, the Board issued Memorandum Circular No. 2019-051 also known as the “Amendment to Memorandum Circular No. 2018-026 (Reduction in the Minimum Number of Units per Application)” to REDUCE the minimum number of units per application to twenty-five (25) units and that the maximum remains at one thousand (1,000) units;

WHEREAS, on 8 November 2019, AGRIPINA R. MENDOZA filed its application for the opening of additional taxi franchise for Metro Manila including MUCEP area under Memorandum Circular No. 2018-026 with the use of twenty-five (25) taxi units wherein the selection proceedings were thereafter conducted on 18 October 2019;

WHEREAS, AGRIPINA R. MENDOZA has complied with the Legal Qualifications set forth under Memorandum Circular No. 2018-026;

WHEREAS, AGRIPINA R. MENDOZA submitted ten (10) copies of Sales Invoice and Delivery Receipt of ten (10) proposed/applied taxi units with the following details, to wit:

WHEREAS, AGRIPINA R. MENDOZA submitted a duly signed and notarized affidavit of undertaking dated 4 November 2019 wherein the applicant undertake the following:

- A. that the proposed taxi units are compliant with the specifications and standards under the Omnibus Franchising Guidelines and Department of Trade and Industry - Philippine National Standards;

- B. that, applicant initially submits the Sales Invoice/Delivery Receipt of TEN (10) units, another TEN (10) units will be delivered and the necessary documents will be submitted within three (3) months, and the remaining five (5) units within six (6) months as certified by the vehicle manufacturer/supplier reckoned from the date of submission;
- C. that evidence of formal arrangement with suppliers/service providers of GNSS Receiver 24, CCTV (with continuous recording of past hours operation), dashboard camera (at least 24-hours of recording), Pocket Wi-Fi device shall be made available immediately upon the issuance of a Notice of Selection and shall immediately be installed in the units prior to the issuance of Provisional Authority;

WHEREAS, AGRIPINA R. MENDOZA submitted a Certification from Vectras, Inc. dated 23 October 2019 signed by its President - Peter Jones A. Figueroa, that Vectras, Inc. will supply and install V-02 GPS trackers to the proposed twenty-five (25) taxis;

WHEREAS, AGRIPINA R. MENDOZA has complied with the Financial Capability Qualifications set forth under Memorandum Circular No. 2018-026;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to **GRANT** the application of AGRIPINA R. MENDOZA for the opening of additional taxi franchise for Metro Manila including MUCEP area with the use of twenty-five (25) taxi units pursuant to Memorandum Circular No. 2018-026.
