**RESOLUTION NO. 003 Series of 2020**

(Re: Opening of Applications for Issuance of New CPC for the route:  
 Cagayan De Oro, Misamis Oriental – Cotabato City, Maguindanao under  
 Memorandum Circular No. 2019-050)

**WHEREAS**, before this Committee are the applications of RURAL TRANSIT MINDANAO, INC. and ILLANA BAY TRANSPORT COOPERATIVE who submitted their respective qualification documents for the route: Cagayan De Oro, Misamis Oriental – Cotabato City, Maguindanao with authorized Fifteen (15) PUB units, under the selection/qualification process conducted on 16 October 2019;

**WHEREAS**, after due evaluation, **RURAL TRANSIT MINDANAO, INC.** was given a rating of **“PASSED/QUALIFIED”** as it fully complied with the Qualification Requirements - Legal, Technical and Financial Capability Qualifications provided under Memorandum Circular No. 2019-013, while **ILLANA BAY TRANSPORT COOPERATIVE** was given a **FAILED/DISQUALIFIED** rating for failure to submit/include in its qualification documents an undertaking to comply the required number of compliant units, undertaking to comply with the specifications and standard under OFG and DTI-PNS, undertaking to immediately comply with the approved rationalization study, fleet management system with organized vehicle dispatch procedures, evidence of formal arrangement with Automatic Fare Collection (AFC) service provider, copies of letter of support from property owners/managers regarding access to or use of, each off-street loading and unloading area in the route map, manner of acquisition for the compliant PUV units identifying the funding source, and although a financial projection was submitted, it did not comply the 5-year required projection;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to **AWARD** the Cagayan De Oro, Misamis Oriental – Cotabato City, Maguindanao route in favor of **RURAL TRANSIT MINDANAO, INC.**
