**RESOLUTION NO. 026 Series of 2020**

(Re: Submission of documents by Barangay Paliparan 3 Transport Cooperative relative to its application for the route Brgy. Paliparan, Dasmariñas, Cavite to PITX via Molino under MC No. 2018-027)

**WHEREAS**, on 4 December 2019, the Qualification Committee issued its Resolution No. 305 S. 2019 wherein the committee resolved to DIRECT Barangay Paliparan 3 Transport Cooperative to SUBMIT within fifteen (15) days from receipt of the aforementioned Resolution its *undertaking to immediately comply with the approved LPTRP or DOTr rationalization study*;

**WHEREAS**, Barangay Paliparan 3 Transport Cooperative received the above-mentioned resolution on 20 December 2019;

**WHEREAS**, on 23 December 2019, Barangay Paliparan 3 Transport Cooperative submitted its signed and notarized *Affidavit of Undertaking for immediately comply with the approved rationalization study* dated 23 December 2019 which stated thus:

“3. That Barangay Paliparan 3 Transport Cooperative will immediately comply with the approved LOCAL PUBLIC TRANSPORT ROUTE PLAN or DEPARTMENT OF TRANSPORTATION route rationalization study;”

**WHEREAS**, upon careful evaluation, the Qualification Committee finds that the submitted Affidavit of Undertaking is compliant with the requirements set forth under Memorandum Circular No. 2019-013;

**WHEREAS**, Barangay Paliparan 3 Transport Cooperative were given a rating of “PASSED/QUALIFIED” as it fully complied with the Qualification Requirements - Legal, Technical and Financial Capability provided under Memorandum Circular No. 2019-013;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to **AWARD** and **AUTHORIZE** the applied thirty (30) UV units for the route Brgy. Paliparan, Dasmariñas, Cavite to PITX via Molino under Memorandum Circular No. 2018-027 in favor of Barangay Paliparan 3 Transport Cooperative.
